This document provides an implementation progress update for the 59 countries for which SOFF Readiness funding has been approved. It notes considerable progress in most of the 36 countries with Readiness funding requests approved in March and June 2023. The 23 countries with Readiness funding requests approved in September 2023 started implementation in October.

The first group of 6 frontrunner countries already completed the SOFF Readiness phase and submitted an Investment Funding request (Decision 6.3). It is expected that by June 2024 in total about 25 Investment funding requests will be submitted to the SOFF Steering Committee, as reflected in the updated SOFF work programme (Decision 6.6).



SOFF Implementation Progress

1. SOFF Portfolio

The SOFF portfolio currently includes 62 countries that were programmed through three SOFF Steering Committee decisions (<u>Decision 3.4</u>, <u>Decision 4.4</u>, <u>Decision 5.4</u>) starting November 2022. Out of these 62 countries, so far Readiness funding has been approved for 59 countries (<u>Decision 4.3</u>, <u>Decision 5.3</u>, <u>Intersessional Decision 1.1</u>). Three countries have not yet accessed Readiness funding, namely Sudan, Haiti, and Guatemala. In Sudan, all SOFF-related activities have been suspended due to the political situation. Haiti has submitted a Readiness funding request for consideration and decision by the 6th Steering Committee (Decision 6.2) and Guatemala is expected to submit a funding request to 7th Steering Committee meeting.

The table below provides an overview of the portfolio of the 59 countries currently implementing the SOFF Readiness phase.

2. Readiness phase progress overview

The implementation of the Readiness phase in the 36 countries included in the first and second programming batch shows substantial progress, with six countries already moving into the Investment Phase (decision 6.3). The countries that were programmed in the third batch started implementation in October 2023.

While the initial assumption was that the Readiness Phase could be completed in six months, given the diverse country contexts and the capacity constraints of some beneficiary countries, it has been observed that on average approximately 9 months are required to deliver all the three Readiness outputs, namely the GBON National Gap Analysis (NGA), the GBON National Contribution Plan (NCP) and the Country Hydromet Diagnostics (CHD).

Allowing flexibility in the implementation is crucial for the successful completion of the Readiness Phase and it should be noted that the delivery of the outputs is not always sequential. The SOFF Secretariat monitors the implementation of activities using an output-based approach and regularly communicates and assists countries and peer advisors as needed.

The following sections break down the SOFF Readiness implementation progress overview by batch.

2.1. First Batch

The first batch of 26 countries accessing Readiness funding started the implementation of Readiness activities in April 2023. 16 peer advisors and 7 implementing entities are engaged in the implementation of the Readiness activities in these countries. The figure below provides an aggregated overview of progress.



First batch: Readiness Implementation Progress




Figure 1. Progress of SOFF first batch countries.

Out of the 26 countries, 25 are currently in the process of delivering their Readiness outputs and most countries are close to completion. Activities were temporarily suspended in Ecuador and Burkina Faso due to security concerns related to political instability and presidential elections. In Guyana, activities were delayed due to health issues and temporary absence of key partners. The peer advisors promptly communicated to the SOFF Secretariat the challenges encountered, the measures taken and how these would impact the delivery of the activities. Currently, the activities in the three countries have been resumed.

Tuvalu has shown significant delay in the implementation due to challenges faced by the peer advisor in liaising with the beneficiary country, but works are now progressing.

The Democratic Republic of Congo will begin the implementation of the activities in December 2023, as indicated in the funding request, due to the risks associated with the election period.

Six countries have completed the Readiness Phase and have submitted an Investment Phase Funding Request that is presented to the 6th Steering Committee for its consideration. Many countries are expected to complete all activities by March 2024, potentially moving into the Investment phase in the second quarter of 2024.

The table below presents the status of the delivery of the Readiness outputs for each country in the first batch.



2.2. Second Batch

The 10 countries programmed in the second batch started implementation in July 2023 with the support of 7 peer advisors and 5 implementing entities. All 10 countries are on track to deliver their Readiness outputs as stated in their respective funding documents. A SOFF regional workshop on Atlantic SIDS will be conducted in November where all partners will address challenges and lessons learnt from SOFF Readiness phase implementation and plan coordinated SOFF Investment phase activities in the three Atlantic SIDS, namely Cabo Verde, Guinea Bissau and Sao Tome and Principe.

2.3. Third Batch

The third batch of Readiness Funding requests was adopted through inter-sessional Steering Committee decision in September 2023. This batch includes 23 countries and one addendum to a previously approved funding request. 10 peer advisors and 7 implementing entities are supporting these countries.






Figure 3. Overview of delivery schedule in the third batch of countries as indicated in the funding requests.
