Fifth Funders' Forum for the Systematic Observations Financing Facility (SOFF)

7 April 2022

Summary of the Chairperson

I. Introduction

- The fifth meeting of the Forum of potential funders for the SOFF was convened virtually by the World Meteorological Organization (WMO), the United Nations Development Program (UNDP) and the United Nations Environmental Programme (UNEP) on 7 April 2022, 13:00-15:00h CEST.
- 2. Delegations from 24 potential funders attended the meeting. In addition, 24 delegations from SOFF stakeholders participated, including beneficiary countries, members of the Alliance for Hydromet Development, civil society organizations and scientific and technical partners. WMO, UNDP, UNEP and UNMPTF leadership and staff joined the meeting. Johannes Linn, SOFF Global Facilitator, chaired the event. (See the list of participants in Annex I).

II. Welcome

- 3. WMO Secretary-General, Prof. Taalas, opened the Forum and shared with the participants that the United Nations Secretary-General António Guterres announced on 23 March 2022 a new United Nations target to ensure every person on Earth is protected by early warning systems within five years. He informed that the UN Secretary-General asked WMO to spearhead this effort and to present an action plan at COP27 in November. He emphasized that SOFF is a foundational element of this action plan. Prof. Taalas also reported on the strong support for SOFF expressed by participants at the "Lahti Adaptation Finance Ministerial" in Lahti, Finland, on 3-4 April 2022.
- 4. UNDP Associate Administrator Ms. Usha Rao-Monari thanked Austria and the Nordic Development Fund for their early contributions to the SOFF United Nations Multi-Partner Trust Fund (UNMPTF). She pointed out that gaps in weather and climate data, especially in SIDS and LDCs, limit their ability to monitor local climate and restrict countries' ability to understand risks and implement meaningful adaptation measures. She encouraged donors to join SOFF by June 2022. Dr. Jian Liu, Director of the Science Division of UNEP, stressed the importance of information and science to address climate change. Ms. Inger Andersen, UNEP Executive Director, reminded the participants via pre-recorded video of the importance of science and data underpinning mitigation and adaptation action and thanked participants for the progress made. Ms. Jennifer Topping, Executive Coordinator of the UNMPTF Office, thanked all the participating organizations for their engagement with SOFF and welcomed the support from funders for SOFF as a foundational initiative in support of resilient development and climate action. She indicated that many of the participants are already contributors to other UNMPTFs, and that the UNMPTF Office is ready to assist the SOFF potential funders and accompany them throughout the pledging process.
- 5. The Chair noted that the purpose of the meeting was to share information on the activities since COP26 and on the preparatory activities for the next few months for opening SOFF doors for business in June; and to provide an opportunity for funder delegates to brief participants on the status of their preparations to pledge their financial support for SOFF. III. Progress on SOFF

6. The SOFF Secretariat reported on the progress of SOFF, including the role of the Facility in supporting weather and climate data for resilience (COP26 and looking ahead to COP27), SOFF milestones in 2022, SOFF governance, SOFF operations, resource mobilization, and 2022 targets. The team informed the participants that SOFF will host its first Steering Committee meeting on 29-30 June 2022 and plans to start operations as of 1 July 2022. All funders with firm pledges by June will be able to join the Steering Committee as founding donors, adopt the SOFF governance and approve the first-year work plan and budget. A firm pledge consists of a publicly announced political



commitment to contribute a specific amount to the SOFF UNMPTF. If needed, financial commitments can be carried out later in the year or in 2023. Two additional Steering Committee meetings are planned for 2022, one in late September and another in November, at COP27. Two Advisory Board meetings are envisaged, one in early September and another in mid-October. The WMO Secretariat reported on the progress of the Global Basic Observing Network (GBON) implementation guidance and preparatory tasks. The SOFF Secretariat concluded the presentation by summarizing SOFF 2022 ambitious targets: (a) opening doors for business in July, (b) funding allocations for up to 20 beneficiary countries by November and (c) COP27 outcomes reflecting the importance of systematic observation and SOFF for climate action.

IV. Discussion

- 7. Participants welcomed the progress of SOFF in terms of both the growing financial contributions and the preparation of the operational and governance arrangements. The discussion revolved around the following areas: (i) requests for more details on progress on cooperation between SOFF implementing entities and the SOFF Secretariat; (ii) a question on public access to GBON data; (iii) whether and how funders can join the Steering Committee after June 2022; (iv) how funders might terminate their engagement with SOFF during the 10-year plan period if needed; (v) whether the scope of SOFF also covers marine-based observation and (vi) whether it would be appropriate to have the Climate Risk and Early Warning Systems (CREWS) initiative join the SOFF Advisory Board.
- 8. SOFF Secretariat and WMO staff responded that (i) intensive consultations with SOFF implementing entities are currently proceeding to identify hydromet and climate programmatic opportunities in which SOFF support can be integrated; (ii) weather observation data will be freely accessible in line with WMO data policy and GBON regulations; (iii) funders will join the Steering Committee as soon they have entered a firm pledge; (iv) SOFF will operate in a phased approach, with the first three-year period beginning in July 2022; funders who joined this period may consider joining subsequent periods; (v) in terms of marine observations, GBON regulations include particular requirements for SIDS that take into account the Exclusive Economic Zone; however, other marine observations are yet to be dealt with as GBON advances; and (vii) the SOFF Secretariat will explore with CREWS whether it would prefer to stick with its membership of the Steering Committee, as presently proposed, or whether it would be more appropriate to join the Advisory Board instead.

V. Funders and Beneficiary countries' statements

- 9. Several funder representatives expressed their strong support and intentions to contribute financially to the SOFF UNMPTF and noted their appreciation of the hard work of the SOFF team and partner organizations. Austria and the Nordic Development Fund delegates confirmed their firm pledges for EUR 4 M and EUR 10 M, respectively. They noted that financial contributions will be made available in time for the startup of SOFF operations on 1 July 2022. The Nordic Development Fund indicated its readiness to co-host the first Steering Committee with one of the Nordic countries in line with the strong Nordic leadership to establish SOFF. Other funder delegates reported on progress with the preparation of pledges by June 2022 and their intention to join the first Steering Committee meeting as founding donors. This group includes Denmark, who announced an intended contribution of EUR 3.4 M, pending final ministerial approval; Iceland, who announced their intention to join the group of SOFF founding donors; Norway, who indicated the intention to finalize a firm pledge by June, subject of final governmental approval; Spain, that indicated the intention to make a contribution to the SOFF UNMPTF; and Ireland, who confirmed the intention to become a SOFF founding member and is finalizing the preparations for their contribution. Other funders reiterated their political support for SOFF and commitment to continuing to explore ways to contribute to the SOFF UNMPTF, including Finland, Sweden and Belgium.
- 10. Representatives of AOSIS and the LDC Group expressed their strong support for SOFF and welcomed their organizations' participation in the SOFF Steering Committee. They thanked those funders who had already pledged and urged others to join SOFF with their financial support. They congratulated the founding UN agencies and the SOFF team for their effective work. Country delegates also reiterated the importance of systematic observation for climate action and their strong interest in supporting the positioning of this topic and SOFF at COP27. Representatives from Belize



and Tanzania encouraged the Forum participant countries to support a COP decision at COP27 that reflects the importance of systematic observation and SOFF.

VI. Closing

- 11. In his closing statement, the WMO Secretary-General thanked all participants for their interest and support, and for their helpful engagement throughout the SOFF preparation process. He thanked especially those funders who had already announced a firm pledge. He expressed his appreciation for the UN partners and other stakeholders actively engaged with SOFF. He reiterated that SOFF will be a key component of the action plan to ensure early warning coverage of all citizens within five years, to be presented at COP27. He expressed his willingness to engage further with principal organizations supporting climate action in order to ensure the success of this initiative.
- 12. The Chairperson delivered a provisional summary of the event. He noted that statements during the meeting confirmed the expectation that SOFF can count on at least 10 firm pledges by the end of June 2022 and can open its doors for operations on 1 July 2022. The Chairperson closed the meeting by thanking all participants for their engagement in the SOFF process and for the encouraging statements of support by funders. He thanked the SOFF Secretariat, WMO, UNDP, UNEP and UNMPTF, and all those who made this event possible working behind the scenes.
