#### **Summary**

#### Highlights of key achievements

The SOFF UNEP Investment Phase in the Maldives made progress in the period between 31 March 2025 and 30 June 2025, with activities generally consistent with the planned timeline and prior reporting. Major achievements included the successful conduction of the inception workshop, endorsement of the Terms of Reference (ToR) for the Project Steering Committee (PSC), and its inauguration. Furthermore, the workplans for Year 2 and Year 3 were jointly developed by the United Nations Environment Programme (UNEP), Maldives Meteorological Service (MMS), Regional Integrated Multi-Hazard Early Warning System for Africa and Asia (RIMES), and Finnish Meteorological Institute (FMI) prior to the inception workshop and were presented to the stakeholders during the event. Planning for the procurement of one Automated Weather Station (AWS), installation of sensors and loggers at four existing surface weather stations, and related civil works is ongoing in coordination among MMS, RIMES, FMI, and UNEP. The establishment of the Project Management Unit (PMU) at the Maldives Meteorological Service (MMS) is also in progress but had not yet been finalized as of the reporting period, with two staff currently being recruited. In parallel,



recruitment efforts are ongoing for five new technical staff and three IT personnel in preparation for the new surface observation station planned in Maafaru. Regular monthly coordination meetings among MMS, RIMES, FMI, and UNEP continue to ensure effective implementation and alignment across all partners.

The face-to-face <u>inception workshop</u><sup>1</sup> and the inauguration of the Project Steering Committee (PSC), part of **Output 1.1—National consultations including with civil society organizations (CSOs) and other relevant stakeholders**—were conducted on 3 June 2025 in Malé, Maldives. The event was attended by the Minister of State for Tourism and Environment, as well as participants from the MMS, UNEP, RIMES, FMI, and other national stakeholders, including representatives from UNDP Maldives, the Ministry of Tourism and Environment, Ministry of Agriculture and Animal Welfare, National Institute of Education, Aviation Services, Maldives National University, and the Fishermen's Association. A total of 43 participants attended out of 48 invitees, with 67% male and 33% female participation, exceeding the adjusted gender representation target of 30% female participation for the SOFF Investment Phase in the Maldives (please refer to the <u>attendance list</u>).

As part of the inception workshop, MMS presented the <u>Terms of Reference (ToR)</u> for the PSC, which received no objections from the participants, and the Project Steering Committee was formally established. The high-level dialogues on the benefits, coproduction, and ownership of the new national GBON infrastructure are planned for Quarter 4 of 2025 after recruitment of PMU.

Under Output 1.2—NMHS institutional capacity required to operate the GBON network—a refresher training programme was conducted by RIMES in November 2024, as previously reported. An additional capacity-building session is scheduled for July 2025. RIMES is in the process of finalizing the detailed curriculum for this session, which outlines the training objectives, modules, schedule, and target participants, with technical inputs from FMI.

For **Output 1.3—NMHS** human capacity required to operate the **GBON** network—the MMS is continuing efforts to recruit technical staff and establish the PMU. Progress to date includes the development of Terms of Reference, candidate assessment, and evaluation. The recruitment process is ongoing and has required additional time to accommodate administrative procedures, including legal approval processes

coordinated through the Ministry of Finance. Recruitment and establishment of the PMU are expected to be completed in Quarter 3 of 2025.

Progress has also been made under **Outputs 2.1 and 2.2—New Land-Based Stations, Improved Land-Based Stations, and related equipment, ICT systems, data management systems, and standard operating practices**. Procurement packages are being prepared for one new AWS, the rehabilitation of four existing AWS, and associated civil works. MMS and RIMES are jointly carrying out these activities, with technical input from FMI. Completion is expected by the end of 2025.

For **Output 2.3—Improved Upper-Air Stations**, **related equipment**, **ICT systems**, **data management systems**, **and standard operating practices**—implementation is scheduled for Year 3. Planning is underway to define technical specifications and procurement requirements, drawing on partner expertise to ensure alignment with GBON standards and national operational needs.

Under **Outputs 3.1** and **3.2—GBON** land-based and upper-air stations' commissioning period—RIMES is leading the procurement of spare sensors for temperature, humidity, atmospheric pressure, and wind for the AWS, as well as spare components including balloons and radiosondes for the upper-air stations. These items are expected to be delivered by the end of 2025.








3 June 2025 – Inception Workshop for SOFF Investment Phase in the Maldives
